

POL002 - ENVIRONMENTAL & SUSTAINABILITY

Supreme Coatings Limited is a professional and environmentally conscious organisation that acknowledges our operations' environmental impact. Our clear aim is to minimise any impact on the environment by:

- Protecting the environment by preventing pollution, reducing waste, and ensuring wherever practicable that measures are implemented to protect and preserve natural habitats, and ecosystems and ensuring compliance with biodiversity impact measures reducing contamination effects.
- Considering our operations' effects on the local community and its biodiversity variations.
- Taking action to eliminate or reduce as far as practicable any potentially adverse environmental impacts by ensuring adequate assessment and sufficient control measures.
- Promoting environmental awareness amongst our suppliers, subcontractors, and partners by implementing operational procedures.
- Seeking to work in partnership with the community by behaving in a considerate and socially responsible manner and encouraging biodiversity drive.
- Ensuring effective and expedient incident control, investigation, and reporting.

Company Directors shall ensure that environmental objectives within the framework of this Policy are continually set to promote continual improvement in our Environmental Management System which will enhance our performance.

Managerial and supervisory staff have responsibilities for the implementation of the Policy and must ensure that environmental issues have adequate consideration in the planning and day-to-day supervision of all work.

Supreme Coatings will fully comply with the duties placed upon it within the requirements of legislation, whilst always complying with, as a matter of best practice, the requirements and duties set out within Approved Guidance as issued by the Environment Agency and any other relevant organisations. As part of Supreme Coatings commitment to maintaining the highest levels of environmental management, it is the intention that the company will adhere to Environmental Management Systems compliant with the latest version of ISO 14001.

All employees and subcontractors are to cooperate and assist in the implementation of this Policy, whilst ensuring that their own works, so far as is reasonably practicable, are without risk to themselves, others or the environment. This includes cooperating with management on any environment-related matter.

Supreme Coatings will take all practical steps to identify any potential hazards or risks to the environment and that suitable and effective preventive and control measures are in place. All employees will be provided with the necessary resources, equipment, information, training, instruction and supervision to fulfil the requirements of this Policy.

The Directors have overall responsibility for all environmental matters.

Monitoring and review will be on a regular basis the operation of this Policy and the associated procedures to ensure they remain current and applicable to the company's activities.
